SOFTBALL PLAYER WAIVER AND RELEASE

I, the undersigned player, acknowledge, agree and understand that:

1. I understand that ALL playing rules governing league play will come from the Softball Official Rule Book and Guide as published by the National Softball Association (NSA). As well as the rules and regulations that have been provided by the Brooksville Parks and Recreation Department and these rules will take precedence over the Official Rule Book.
2. Voluntarily and of my own free will, I elect to participate as a member of the softball team and league indicated below.
3. I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, including, but not limited to those hazards associated with weather conditions, playing conditions, equipment and other participants.
4. I understand that sliding into bases is dangerous to me and to other players and may result in serious injury or death.
5. I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding and diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I, the undersigned player, agree that in consideration for the right to play as a member of the team designated below and in consideration for permission to play on the fields arranged for by the team or league:

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me [a] while practicing or playing as a member of the team so designated, [b] while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and [c] while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play.
2. I release, discharge and agree not to sue the team and league designated below or any field on which softball is practiced or played by my team., or their owners, officers, agents, servants, associations, employees, or any person or entity connected with the team, league, field for any claims, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me.

PLAYER CODE OF CONDUCT

The following "Player Code of Conduct" will be strictly enforced during the coming season. It is the manager's responsibility to ensure that all their players adhere to these rules before, during and after all games.

No player shall:

- At anytime lay a hand upon, shove, strike or threaten any player, official, spectator, or city personnel.
- Physically attack another player, official, spectator or city personnel.
- Verbally attack any player, official, spectator or city personnel.
- Use severe vulgarities directed at any player, official, spectator or city personnel.
- Use "Casual Profanity". Casual profanity pertains to expletives and verbal unsportsmanlike language not necessarily directed at officials or opposing players, but is uttered by a player out of frustration.
- Smoke on field or around dugouts.

Player shall:

- Abide by official's decision. Player will be guilty of an objectionable demonstration of dissent at an official's decision.
- Leave recreation facility immediately if ejected from game or facility by official or city personnel.
