

**BID OPENING MINUTES

A opening for Bid No. CD2018-01 was held at 3:00 p.m. on Friday, April 6, 2018 in the Joseph E. Johnston, III, City Council Chambers at 201 Howell Avenue, Brooksville, FL for the COMMUNITY DEVELOPMENT DEPARTMENT WATER TOWER SITE IMPROVEMENT PROJECT – CD2018-01. In attendance were Jennifer J. Battista, recording secretary and Admin Assistant with the City's Community Development Department and Burt Bennett, Coastal Engineering, CRA consultant for the project.

Also in attendance were representatives from Daly & Zilch (Florida), Inc. and Right of Way Contracting, Inc.

Recording Secretary Battista advised that the Invitation to Bid for a March 23, 2018, bid opening was advertised on February 9, 2018 and advertised again on March 23, 2018, extending the bid opening date to April 6, 2018. Eight (8) addendums had been issued and posted on the City's website.

As a result, three (3) bids were received, all properly sealed and notated. The following three (3) companies submitted a bid, which were opened and the results read as follows:

An original and 3 copies were submitted as required. All 8 addendums were acknowledged. Bid bond for \$8,500 was submitted. A maximum 90 days was listed for completion.

**Total Lump Sum Bid Amount: Bid: \$166,907.00**

An original and 3 copies were submitted as required. All 8 addendums were acknowledged. Bid bond for 5% of the bid was submitted; specific amount not given. A maximum amount of days to complete was not listed.

Recording Secretary Battista advised that the consultant, City staff and the City Attorney would review the proposals received for compliance and/or deficiencies. Award of bid should be considered by Council at a meeting in May, 2018. Consultant Bennett advised that after award of bid, it would take approximately 30 days to execute the contract and construction on the project would begin thereafter.

The bid opening was adjourned at 3:07 p.m.
