PRECAUTIONARY BOIL WATER NOTICE

DATE, TUESDAY, AUG. 13th 2019

This is to advise that on Tuesday AUG. 13TH 2019, water service will be interrupted while City Utilities Service completes repair of a 6 inch water line. Water service interruption will be approximately eight (8) hours starting at 9:00 am.

When water service is interrupted, as a precaution, the City of Brooksville, Department of Public Works, advises that all water used for drinking or cooking be boiled. The U.S. Environmental Protection Agency has determined that a rolling boil of one (1) minute is sufficient to disinfect water. As an alternative, bottled water may be used for drinking and cooking. Water from the City's system after repairs are complete is approved for bathing and cleaning purposes only. Clearance for drinking and cooking will be determined by bacteriological examination.

This "Precautionary Boil-Water Notice" will remain in effect until satisfactory water samples are obtained confirming that the water is safe for drinking or cooking. You will be notified by a handout when the system is cleared for normal use. We expect this to be in 3-5 days.
